 am eligible to hold a driver licence and may result in restrictions being paced on, the suspension of, or the cancellation of, any
 driver licence that I hold.
- I also confirm that I have read and agree with, the privacy statement. Our Privacy Statement explains why we are collecting your Personal Information and how we will use and manage it in accordance with the Privacy and Personal Information Act 1998, and, where relevant, the Health Records and Information Privacy Act 2002. Roles and responsibilities of the driver

In all States and Territories, legislation requires a driver to advise their Driver Licensing Authority of any long-term injury or illness
that may affect their safe driving ability. These laws may impose penalties for failure to report. As well as these legal obligations, a
driver may be liable at common law if they continue to drive knowing that they have a condition that is likely to adversely affect safe
driving.

Important information

- This medical report must be completed by an appropriate Specialist Medical Practitioner, experienced in the treatment of medical condition(s) relevant to the person listed below.
- The medical report should be completed by one Specialist Medical Practitioner only, if more then one Specialist assessment is required, a separate medical report must be used for each case.
- Please take the time to read the attached 'Information for the Applicant and Specialist Medical Practitioner' Information Sheet.
- In many cases it is necessary for information to be provided from an appropriate specialist medical practitioner before Transport for NSW can allow the issue of a driver licence, or provide approval for a driver to maintain a licence.
- If you are required to undertake a specialist medical assessment it is recommended that you make an appointment as soon as practicable, as in some areas of NSW appoints with specialist medical practitioners can involve long waiting lists. Once you have obtained an appointment with the specialist medical practitioner(s) it is suggested that you provide Transport for NSW with confirmation of your appointment to ensure that our records can be updated.
- The responsibility for issuing, renewing, suspending or cancelling a person's licence (including conditional licence) lies with Transport for NSW. Licensing decisions are based on a full consideration of relevant factors relating to health and driving performance. Accordingly, you should make the specialist medical practitioner aware of any medical conditions you may have.
- Please note: It is a legal requirement for any costs associated with the medical examinations(s) to be met by the licence holder. It is recommended that you present this information document to your specialist medical practitioner when you attend your appointment.

Instructions for Specialist Medical Practitioner

The examination must be completed in accordance with the published national 'Assessing Fitness to Drive' for commercial and private vehicle drivers medical standards for licensing and clinical management guidelines, published by Austroads. In accordance with the medical standards all commercial drivers will require a specialist opinion for any serious medical condition.

Please note that any information that is not relevant to the patients' fitness to drive should not be included on this report.

It is important that you undertake the examination in accordance with the medical standards relevant to the class of licence held or applying for, and also take into consideration the nature of the persons driving task.

Please ensure Specialist Medical Practitioner Certification (Part D) is completed in all cases and also ensure the patient reads and signs the 'Driver/applicant declaration and privacy statement'.
